2022-2023 USD 325 AUDIT REPORT

Denis Miller reviewed the 2022-2023 audit report submitted by Mapes and Miller. Shawn Hoover moved the Board accept the audit as presented for 2022-2023. Rick Dusin seconded the motion. Motion carried 6-0.

REPORT TO THE BOARD BY THE SUPERINTENDENT

The Superintendent shared the spring school nurse report for the 2023-2024 School Year. Mr. Gower then discussed E-rate and the requirements of the Children's Internet Protection Act (CIPA) to filter internet content accessible to students. Following discussion, Brock Johnson moved the Board approve the internet safety policy complying with the requirements of CIPA. Danielle Bohl seconded the motion. Motion carried 6-0.

Mr. Gower shared that the Kansas State Department of Education determined the district's general fund budget should be more than the amount the district approved for the 2023-2024 budget year. Mr. Gower recommended republishing the 2023-2024 budget's general fund, so the district will have the authority to spend the additional funds. This will not change property taxes. Following discussion, Danielle Bohl moved the Board approve publishing the Notice of Hearing on Amending the 2023-24 Budget on Monday, June 10, 2024 at 6:05 p.m. at the Board of Education office. Shawn Hoover seconded the motion. Motion carried 6-0.
